## Definitions

For the purposes of this Cookie Policy, the following definitions apply:

**Cookies** are small files that are placed on your computer, mobile device or any other device by a website, containing the details of your browsing history on that website among its many uses.

**Country** refers to South Africa.

**Device** means any device that can access the internet or our website, such as a computer, a cellphone or a digital tablet.

**Personal Data** is any information that relates to an identified or identifiable individual.

**Service Provider** means any natural or legal person who processes the data on behalf of The Afriq Water Group. It refers to third-party companies or individuals employed by The Afriq Water Group to facilitate our website, to provide our products and services on behalf of The Afriq Water Group, to perform services related to our products and services or to assist The Afriq Water Group in analyzing how the website is used.

**Usage Data** refers to data collected automatically, either generated using our website or from our products and services, and our website infrastructure itself (for example, the duration of a page visit).

### **Type of Cookies We Use**

Cookies can be "Persistent" or "Session" Cookies. Persistent Cookies remain on your personal computer or mobile device when you go offline, while Session Cookies are deleted as soon as you close your web browser.

We use both session and persistent Cookies for the purposes set out below:

- Necessary / Essential Cookies
  - Type: Session Cookies
  - Administered by: Us
  - Purpose: These Cookies are essential to provide you with services available through the website. Without these Cookies, the services that you have asked for cannot be provided, and we only use these Cookies to provide you with those services.
- Functionality Cookies
  - Type: Persistent Cookies
  - Administered by: Us
  - Purpose: These Cookies allow us to remember choices you make when you use the website, such as remembering language preferences. The purpose of these Cookies is to provide you with a more personal experience and to avoid

you having to re-enter your preferences every time you use the website.

### **Your Choices Regarding Cookies**

If you prefer to avoid the use of Cookies on the website, first you must disable the use of Cookies in your browser and then delete the Cookies saved in your browser associated with this website. You may use this option for preventing the use of Cookies at any time.
